Detention Pond Update - Spring 2018

The township has strict rules concerning detention ponds for maintenance and landscaping. Please see ordinance 170-24.8 (https://ecode360.com/16146445), which sets the standards for detention pond landscaping. Failing to comply with maintenance rules would prompt the township to make the improvements and the HOA to pay the cost of the work. Please see the respective ordinance Chapter 151: Stormwater detention basin maintenance (https://ecode360.com/8500372)

To be in compliance the Detention Basin committee has been working on two fronts: pond maintenance and mitigation

- a) Maintenance: **yearly** cleaning of the inlet/outlet plus addition of material lost to erosion.
- b) Mitigation: several actions were taken to improve the porosity of the soil in the pond that will, in turn, improve the drainage. The first was to stop the grass cutting in the pond area which compressed the soil underneath in detriment of the drainage. The second action was the planting of native water-tolerant trees, which improve the soil and the water absorption and remove contaminants. Thirty-two saplings of native trees such as Black Gum, Dawn Redwood, Bald Cypress, River Birch, Swamp Oaks, Red and White Cedar were planted, as well as several Elderberries bushes. After one year, about 80% of the saplings have survived. We are anxiously awaiting spring to see how many survived the second year. Based on the success of certain species the committee will plant more natives as recommended by the ordinance mentioned above.
